**IMPORTANT:** If you are unsure if you qualify for your first U.K. passport, you must complete the assessment form included in this kit. It is highly recommended that people who are not absolutely certain they can claim U.K. citizenship also complete the assessment form.

1. Please complete your U.K. passport application and have 2 photos taken and signed by a guarantor. A photo specification page is included in this kit).
2. Fax us your U.K. passport application, a copy of your birth certificate, certified copies of your photo ID, any additional documents you require based on the grid below and this order form to: **416-640-2650**.
3. We will call you to confirm the receipt of your fax and discuss your case
4. When instructed to do so, please send in all the required documents on the checklist to: **1180 DANFORTH AVE, TORONTO, ON M4J 1M3**
5. Once we have received your new passport from the U.K. Embassy, we will contact you to arrange delivery.

## U.K. PASSPORT PHOTOS: SPECIFICATIONS

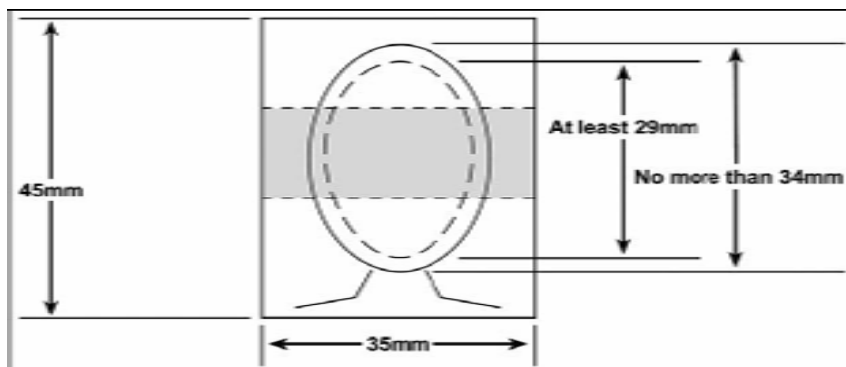

The photos must be according to the following criteria:

- **IN COLOUR**  
(Do not submit black & white photos)
- **TAKEN BY A PROFESSIONAL PHOTOGRAPHER**  
(Do not submit photos printed from home)
- **TAKEN WITHIN THE LAST MONTH**  
(Ensure they are dated)
- **TAKEN ON A WHITE BACKGROUND**
- **NEUTRAL EXPRESSION WITH CLOSED MOUTH**  
(No smiling, grinning, frowning)
- **SIZE MUST FOLLOW THE TEMPLATE GIVEN BELOW**
