MONEY-BACK GUARANTEE:

Please read Section E to learn about our money-back guarantee policy.

The Client retains Immigroup Immigration Services as representatives with respect to Canadian immigration matters of the Client and his accompanying family members. Immigroup Immigration Services will provide the Client with the following services:

1. Assist, counsel, and prepare the Applications for Permanent Residence in Canada and supporting documents on behalf of the Client, to be submitted to Citizenship and Immigration Canada.
2. Assist, counsel, and prepare the Client, in person or by phone, for an interview, should one be required by Citizenship and Immigration Canada as part of the process of the Client's application for permanent residence.
3. Provide the Client with copies of the Application, supporting documents, and correspondence relevant to the Application.
4. Follow up with Citizenship and Immigration Canada, when necessary, regarding the status of the Client's application, from the time the Application for Permanent Residence is submitted to Citizenship and Immigration Canada until a final decision is made with respect to the Application.

The Client agrees to:

1. Inform Immigroup Immigration Services of any correspondence or communication received from Citizenship and Immigration Canada regarding the Client's Application for Permanent Residence, and provide Immigroup Immigration Services a copy of such correspondence or communication.
2. Inform Immigroup Immigration Services of any change in the Client's information or circumstances relevant to the Client's Application for Permanent Residence.

The Client acknowledges and agrees that:

1. The Immigration and Refugee Protection Act or Regulations may, at any time, be subject to changes or amendments that could affect the

outcome of the Client's Application for Permanent Residence in Canada.

2. The Application for Permanent Residence in Canada will be submitted to the Canadian Visa office that has jurisdiction of the country where the Client is residing provided the Client has been lawfully admitted to that country for at least one year; or to the Canadian Visa office that has jurisdiction of the country of the Client's nationality.

A. FEES AND METHOD OF PAYMENT:

Immigroup Immigration Services will charge a service fee of US\$1500 for providing the above mentioned services to the Client. This includes legal fees and expenses incurred by Immigroup Immigration Services.

The service fee shall be paid as follows:

1. US\$400 at the time this Agreement is signed by the Client and Immigroup Immigration Services.
2. The outstanding balance of US\$1100 may be paid in installments; however, the full balance must be paid in full before the Application for Permanent Residence and supporting documents are submitted by Immigroup Immigration Services to Citizenship and Immigration Canada.

B. DISBURSEMENTS:

The Client acknowledges and agrees that the service fees of US\$1500 do not include the following Citizenship and Immigration Canada processing fees:

- CDN\$550 for the principal applicant,
- CDN\$550 for the accompanying spouse or common-law partner, and

- CDN\$150 for each accompanying dependent who qualifies as a dependent son or daughter as defined by Canadian immigration law.
- CDN \$490.00 for the Right of Permanent Residence Fee to be paid by the principal applicant and the accompanying spouse or common-law partner. The Right of Permanent Residence Fee is fully refundable if the application is refused by Citizenship and Immigration Canada.
- Any other Government of Canada related fee.

C. REQUIREMENT TO BE TRUTHFUL:

The Client agrees to provide Immigroup Immigration Services truthful and accurate information in all matters regarding the Application for Permanent Residence in Canada. The Client acknowledges that any inaccuracies in the information provided may seriously affect the outcome of the Application.

The Client acknowledges that Immigroup Immigration Services reserves the right to rescind and revoke this Agreement at any time if the information provided to either Immigroup Immigration Services or Citizenship and Immigration Canada is found to be untruthful, misleading or false; or if the Client does not comply with the method of payment of payment outlined in section A.

D. DUTIES OF IMMIGROUP IMMIGRATION SERVICES:

Immigroup Immigration Services shall protect the Client's privacy and treat all information as strictly confidential. Immigroup Immigration Services shall diligently provide those services reasonably required to fully represent and protect the Client's interests, and shall take reasonable steps to keep the Client informed of the progress of all matters regarding the Client's Application for Permanent Residence in Canada, and shall respond to the Client's inquiries in a timely manner. Immigroup Immigration Services shall promptly notify the Client of all significant developments and shall consult in advance with the Client, whenever possible, as to any significant decisions that need to be made. If for any reason the Client cannot be reached, Immigroup Immigration Services shall do what they in their sole discretion determine to be in the overall best interest of the Client.

E. MONEY-BACK GUARANTEE

In the event that the Client's Application for Permanent Residence to Canada is not successful, Immigroup Immigration Services will refund the Client the full amount of service fees. The refund does not apply to:

- Government cost recovery fees, including the Right of Permanent Residence Fees;
- Courier and/or postage costs and expenses related to the Client's file.
- Long distance telephone or facsimile communications.

Immigroup Immigration Service's money-back guarantee does not apply when and if:

- The Client misrepresents information regarding the Client's or any member of the Client's family regarding the selection criteria outlined in the Immigration and Refugee Protection Act and Regulations or any other information relevant to the process of the Application;
- The Client submits fraudulent documents in support of the Application;
- The Client or any member of the Client's family is determined by Citizenship and Immigration Canada to be medically or criminally inadmissible to Canada;
- The Client fails to submit information or documents required by Immigroup Immigration Services or Citizenship and Immigration Canada in support of the Application.
- The Client fails to present Immigroup Immigration Services the letter of refusal of the Application received from the Canada visa office responsible for processing the Application.

The Client ACKNOWLEDGES AND UNDERSTANDS that Immigroup Immigration Services is not a Canadian Government agency, and that Immigroup Immigration Services cannot guarantee the outcome of the Application for Permanent Residence in Canada.

The Client acknowledges receipt of a copy of this Agreement and understands and agrees to its terms and conditions.
