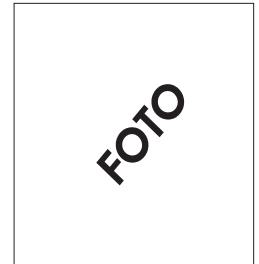

REQUISITOS DE ENTRADA NO TERRITORIO ANGOLANO

* Os estrangeiros podem entrar no território angolano desde que reúnem, cumulativamente, os seguintes requisitos:

- a) Ser portador de passaporte com validade superior a duração de permanência autorizada;
- b) Possuir visto de entrada vigente;
- c) Não estar sujeito a proibição de entrada;
- d) Garantia de meios de subsistência.

Os estrangeiros que desejam permanecer em Angola por um período de tempo superior ao que lhe foi facultado no visto de entrada, pode ser concedido uma autorização de permanência, até 30 dias, prorrogável uma única vez.

REQUIREMENTS

* Foreigners may enter Angolan territory as long as they meet the following requirements:

- a) Be a holder of a passport valid beyond the period of stay;
- b) Have a valid entry visa;
- c) Not be under entry ban;
- d) Guaranteed means of support.

Foreigners, who wish to stay in Angola longer than the allowed period on the entry visa, may be authorized to stay for a period of up to 30 days, extended only once.

DEVERES

DUTIES

* Foreigners who demonstrate desire to stay in the Republic of Angola must:

- a) Respect constitutional law as well as other laws in force in the Republic of Angola;
- b) Declare to Immigration Service their whereabouts;
- c) Not engage in public service, or in exercising power of authority, unless otherwise ruled by international convention or agreement, or in case of technical, teaching, scientific or researching tasks.
- d) Not perform in the Republic of Angola any activity of political nature, neither direct nor indirectly engage in political matters.
- e) Not perform any professional activity subject to legal authorization, without work or residential permit.

DIREITOS

* Os estrangeiros que residem ou se encontram em Angola gozam, na base de reciprocidade, dos mesmos direitos e deveres que os cidadãos angolanos, com excepção dos direitos políticos e dos demais direitos expressamente reservados por lei aos cidadãos angolanos.

Os estrangeiros gozam:

- a) Liberdade de circulação e de domicílio.
- b) Direito de reunião e de manifestação.
- c) Direito a educação e liberdade de ensino.
- d) Liberdade de adesão às organizações sindicais e associações profissionais.
- e) Recorrer aos órgãos judiciais dos actos que violem os seus direitos reconhecidos pela lei constitucional e pelas demais leis em vigor.
- f) Não ser preso em culpa formada, nem sofrer qualquer sanção, a não ser nos casos e pelas formas previstas na lei.
- g) Exercer e gozar pacificamente os seus direitos patrimoniais e não sofrer quaisquer medidas arbitrárias ou discriminatórias;
- h) Não ser expulso ou extraditado senão nos casos e pelas formas previstas na lei.

RIGHTS

* On basis of reciprocity, foreigners who live or who are in Angola, benefit of the same rights and duties as Angolan citizens, except political rights as well as other rights explicitly reserved by law to Angolan citizens.

Foreigners have rights to:

- a) Freedom of movement and residence;
- b) Freedom of meeting and speech;
- c) Right and freedom of education.
- d) Right to join trade unions and professional associations.
- e) Go to justice to claim against acts of violation of their rights recognized by the constitutional law as well as other laws in force.
- f) Not be imprisoned by false accusation, nor suffer any punishment unless in cases pursuant to law;
- g) Exercise and enjoy their properties rights without discrimination;
- h) Not be expelled out or deported unless in cases pursuant to law.

SERVICE FEE INFORMATION

1. CIBT Service Fees:

2. Consular Fees:

Consular and processing fees are determined by the foreign government issuing the visa and are subject to change beyond the control of CIBT. CIBT assesses a 2.49% processing fee on government agency fees only. Consular fees vary by consulate, please refer to requirements

3. Copy Fees:

Please submit a photocopy of your information page of your passport along with all supporting documents, letters, flight itineraries that support your visa request to avoid the photo copy fee. You will be charged a photocopy fee if all documents are not copied and submitted with your original submission.

4. Money Order Fees:

Embassies, Consulates and Government Offices require payment be made by Money Orders. A money order fee of \$8.50 is applied for each money order purchased.

5. Shipping Fees:

CIBT will return your completed documents to you via overnight mail. Additional charges will apply for weekend, same-day, after-hours delivery and shipping to/from USA. You may also provide your own account number for shipping. We utilize Federal Express and Purolator. We do not utilize XpressPoste.
